Additional instructions for Indian Corporate applicants:

1. Application for allotment of PAN through MCA Portal

With effect from February 1, 2017, a facility has been provided on the portal of Ministry of Corporate Affairs (MCA), i.e. www.mca.gov.in for the corporate applicants to apply for registration of a new company alongwith application for allotment of PAN & TAN by submitting their application using a common application form (i.e., SPICe-INC 32).

- 2. In view of this, for all domestic companies, applications for allotment of PAN (i.e. Form 49A) should be submitted at the MCA portal only, except for the following:
 - (i) Domestic companies <u>incorporated prior to February 1, 2017</u> and where PAN has not been applied;
 - (ii) Domestic companies <u>incorporated from February 1, 2017 onwards</u> and where PAN has not been applied/allotted through Common application form (<u>SPICe-INC 32</u>) of MCA;

3. How to apply for PAN for above exceptional cases of domestic companies:

- (i) Application for allotment of New PAN for the aforesaid domestic companies can only be submitted online using Digital Signature Certificate (DSC) at the DSC based paperless facility hosted by NSDL e-Gov at the following website (https://tin.tin.nsdl.com/pan/form49Adsc.html)
- (ii) PAN application by these companies will <u>not be accepted through any</u> <u>other mode</u> (i.e. TIN-FCs/PAN Centres & other paper mode facilities).

5. Application by foreign companies:

- (i) The above guidelines are applicable only for the domestic companies and will not be applicable for foreign companies.
- (ii) Foreign companies will be able to submit their applications through all the available modes as per the existing procedure.

6. Request for new PAN card or/and changes/correction in PAN Data

- There is no provision for submitting 'Request for new PAN Card or/and changes/correction in PAN Data' through MCA Portal.
- PAN Change request applications can be submitted at <u>TIN Facilitation centres/PAN</u>
 <u>Centres or online</u> through NSDL e-Gov website at <u>www.tin-nsdl.com</u> as per existing procedure.
